

## CHANCERY AND CIRCUIT CIVIL COURT COST - EFFECTIVE JANUARY 1, 2026

**COURT COSTS ARE DUE AT THE TIME OF FILING AND NO COST BOND REQUIRED with the following exceptions:**

1. Attorneys may sign a cost bond in workers' compensation complaints and cases listed under footnote 1. In these cases, the litigation taxes of \$122.50 are payable at the time of initial filing.
2. Initiation of case by pauper's oath

**SHERIFF FEES ARE DUE AT THE TIME OF FILING.  
NO EXCEPTIONS.**

**A separate check shall be included payable to the applicable county sheriff. This includes Williamson County process.**
